## **Treasurers Report**

I have much pleasure on behalf of your Board in presenting the Financial Report for the period ending 30<sup>th</sup> June 2012.

The Club has once again been able to achieve a reasonable Profit of \$ 27,607-00

I would like to congratulate our CEO Melissa and her Staff for their continuing efforts in the successful operation of our great Club.

During the year your Board decided to commission Mr Bob Bullen from the Royal Bowling Association Inc. Club Advisory Committee, to carry out a thorough and independent review of the Operation and Financial Status of the Club. It was felt that such a review would highlight how our Club was operating compared with industry benchmarks.

Mr Bullen concluded that the Board was making the right decisions and that the current strategic planning process be maintained, together with regular reports to the Board on the progress of each of the plans actionable items.

The details of the Profit and Loss Statement are listed in the Annual Report, however below are a number of items that had an influence on the outcome achieved.

I would report that we have been able to significantly reduce the balance on the Building Loan by increasing our Monthly repayments and injections of capital as the income allows.

This reduction in the outstanding balance on the Loan should allow us to completely repay the Loan within our projected 5 year repayment period.

We have also been able to purchase replacement Tables for both the Restaurant and the Tibouchina Room completing our Furniture replacement programme.

In conclusion, I would like to congratulate and thank all the Members, my fellow Board members, our CEO Melissa Brooke and our great Staff who have all contributed to the success of this Financial year.

## Chief Executive Officer's Report 2012

It has been an exciting 12months following the completion of our major Club Alterations and Additions and it has been rewarding to hear the favourable comments from members and visitors about the modern furnishings and facilities your Club now has to offer. Although we have incurred additional expenses directly related to the building works, bank interest and an increased depreciation schedule, it is pleasing to report that your Club has achieved a profit for the year of \$28,550.

Your Board and Management developed four main objectives tabled in the Business Plan for 2011/12. These were based around; growth in the membership data base with the aim to increase patronage and ensure financial sustainability; providing quality customer service and facilities for members; creating a venue of first choice for the community to hold functions and events; and lastly provide facilities for companies and community groups to network and build relationships.

Various strategies were put in place throughout the year to achieve these objectives and a summary of the results are as follows;

- I. Membership as a whole has increased by 21% on last year and 31.5% over the last four years which in turn resulted in all trading areas increasing in turnover except Keno which decreased by -3.16%. Bar turnover increased by 15.7%, Poker Machines by 13.6%, Catering by 725% and TAB showing 62.2% increase.
- II. The introduction of the Poker Machine Credit Clearance Unit decreased member complaints on waiting periods and increased quality customer service to the bar and gaming area.
- III. Due to updated facilities, particularly to the function rooms, together with friendly quality customer service, we have seen an increase number of functions in the private, community, sporting and business sectors representing an approximate 200% increase as a whole.
- IV. Of the 200% increase in functions, community & sporting groups have made a significant return to the club for meetings and events, which include; Probus, Quota, Inner wheel, Rotary, Lions, Shirley Group, NRDWBA Umpires, Country Labour Association, Alstonville Scouts Group, Wollongbar Alstonville Junior Rugby Union, Alstonville &

District Football Club, far North Coast Swimming, Alstonville Netball and Far North Coast Rugby Union Referees Association.

In addition to these results, the Board implemented a program to reduce our business loan liability from a 15year repayment plan to a 5year repayment plan. To make this possible, we have increased our monthly repayments and structured our cash investments to offset the interest expense.

Finally, this result would not have been possible without our wonderful and dedicated staff; their commitment and continuous quality service provided to members and guests have ensured sustained growth in *your local club*.


